UNOFFICIAL TRANSLATION

Crisis Staff for the suppression of Infectious Diseases COVID – 19, at its 34th session held on July 9, 2020 adopted:

CONCLUSION

1. It is recommended that the Government, in order to prevent the occurrence, spread and control of the infectious disease COVID-19 and protect the population from that disease in the city of Belgrade, determine the following special measures to protect the population from the infectious disease COVID-19:
 - Organized gatherings in public spaces indoors or outdoors are allowed only when a maximum of 10 (ten) people gather, provided that there must be a distance of at least 1.5 meters between the gathered persons. Organized gatherings in indoor and outdoor public space are especially considered: celebrations, music, entertainment and cultural events, political gatherings, sports events with the presence of the audience and similar gatherings;
 - The working hours of catering facilities that do not have a garden and foot clubs are limited, so that these facilities will not work starting from 9 p.m. to 6 a.m. the next day;
 - The working hours of catering facilities that have a garden are limited, so that these facilities will not provide catering services in the closed part of the facility starting from 9 p.m. , and in the open part of the facility (garden) starting from 11 p.m. to 6 a.m. the next day;
 - The working hours of shops, shopping malls and other facilities are limited, so that these facilities will not work from 9 p.m. to 6. a.m. the next day, and at the entrances to these facilities must be prominent notice of the total area facility and the number of persons who can stay in that facility at the same time;
 - It is mandatory to wear protective masks in all public closed spaces, i.e. facilities;
 - In public city and suburban transport, as well as in intercity transport, it is mandatory to wear protective masks;
2. In all public closed spaces, i.e. facilities, as well as in all stores, catering facilities, gardens of catering facilities and other facilities, the number of persons who may be present at the same

time is limited, so that at each 4m² only one person may be present. At the entrance to the facility, i.e. in the garden of the catering facility, the area and the number of persons who may be present at the same time must be clearly prominent.

3. The restrictions referred to in line 1, item 1 and line 2 of this conclusion do not apply to the work of business entities that do not provide services to population, as well as to the work of state bodies and public services.
4. The restriction referred to in line 1, item 4 of this conclusion does not apply to pharmacies and gas stations in performing the activity of selling.
5. Measures from line 1 and line 2 of this conclusion are implemented by the Mayor of the City of Belgrade through the competent city bodies and services, the Headquarters for Emergency Situations of the City of Belgrade and City Institute for Public Health Belgrade, in cooperation with the Ministry of Health, competent inspections of state administration bodies and the Ministry of Internal Affairs.
6. Measures from line 1 and line 2 of this conclusion shall apply on the day of the publication of the Decision on determining special measures for the protection of the population against the infectious disease COVID - 19 on the territory of the City of Belgrade.
